

FROM THE PDA CEO

Welcome to the 2016 Pennsylvania's Dental Meeting (PDM)!

I am pleased to report on the state of PDA during the past year with a sense of great accomplishment, but also with hope for a more deliberate pursuit of substantive and objective outcomes that reflect our members' wants and needs.

A large portion of the year was focused on governance issues again. Much like our nation's forefathers, PDA leadership continued to shape our new PDA "nation," addressing unexpected challenges along the way.

- Campaign guidelines were developed and refined to ensure fairness in the
 election process. The election procedure also was fine-tuned and showed an
 increase in the number of engaged members who cast votes. It is clear that
 PDA's message of inclusiveness is being heard.
- At the request of the Council of Presidents, several governance issues were proposed, considered and acted upon.
- Bylaw amendments were adopted to accommodate the governance tweaks that were necessary.
- An extensive analysis of PDA's membership database system was done over a two-year period to consider the suggested conversion to ADA's Aptify database. After careful consideration, the Board of Trustees determined that the Aptify database was not the best fit for PDA.
- At the recommendation of our ADA trustee, the board contracted with Opis LLC to develop a PDA Strategic Plan (page 5) and to conduct a membership survey. These will be the tools your leaders will utilize to move your organization forward.
- The blueprint for future PDM formats and locations has been an ongoing topic of board discussion.
- Monitoring the activities and finances of the PDAIS/Bell acquisition.

Meanwhile, your board maintained a focus on the important substantive initiatives that PDA must develop to remain relevant to our mission and purpose. The new strategic plan was adopted as a framework for constructing those initiatives based on the stated needs and preferences of our members. The three stated goals (Finance, Membership, Organizational), as well as the related objectives and strategies, will be shaped by the results of the recent membership survey. The board is committed to ensuring that PDA's efforts are targeted to substance and fit within our strategic plan. Legislative endeavors are also targeted toward member needs, and financial stewardship is a priority at every meeting.

Unfortunately, due in large part to the legislature's difficulty in passing a state budget, legislative initiatives stalled across the board. However, both your leadership and our experienced dentist advocates, along with our lobbyists and government relations staff, have remained steadfast in pursuing PDA's priority items. They have spent countless hours meeting with legislators to keep PDA and the dental profession positioned favorably.

Financial stewardship has become an increasingly more interesting balancing act for PDA. Declining membership has always been, and continues to be, a predominant theme. However, the Bell acquisition in our for-profit subsidiary has created a ripple effect which negatively impacts the PDA budget, and consequently, much of our programming.

Although the leadership of both PDA and PDAIS expect the impact to be of relatively short duration (5–7 years), we need to tighten our belts. Decisions must be made with laser acuity to stay within our budgetary reality while endeavoring to produce meaningful programming that gives member value.

In spite of the challenges PDA continues to address, I believe your dedicated leadership is committed to moving the new PDA nation forward. My hope is that the majority of "governance growing pains" have been addressed so that we can look beyond the nuts and bolts of "how" we govern ourselves to the substance of "what" is important to you. The new PDA is here to stay; let's plan positively, deliberatively and strategically for our future.

I encourage each of you to forward, through the Council of Presidents, any specific trends that affect your practice or your profession. I invite you to join us at 1:45 p.m. on May 21 for the town hall portion of the PDA Business Meeting. Help your leaders create value as they develop the objectives and strategies that will deliver the tools you need to be successful in your profession.

In 2018, PDA will be marking its 150th Anniversary. Help celebrate Pennsylvania's many contributions to organized dentistry by becoming engaged, participatory and forward thinking so that we can be a proud part of PDA's legacy during the NEXT 150 years.

In the words of former United States Secretary of State George C. Marshall, from Uniontown, Pa., "When a thing is done, it's done. Don't look back. Look forward to your next objective."





2016 AWARD RECIPIENTS

PDA PUBLIC SERVICE AWARD

Since its inception in 2009, the Lehigh Valley Hospital Miles of Smiles Mobile Dental Van has treated more than 7,000 patients and provided \$2.5 million in treatment services at no charge, a huge success largely due to the grant writing efforts of director Patricia Lee Atno and chairman Dr. Charles Kosteva.

Miles of Smiles provides free dental services to low-income, uninsured and underserved children in the Allentown School District. The van features two treatment rooms, a digital X-ray unit, a sterilizing device, registration area and a wheelchair lift. The van serves students in four Allentown elementary schools, with a dentist, dental hygienist, dental assistant and a driver who doubles as a clerk.

In her nomination letter, Dr. Cynthia Olenwine, president of the Second District Valley Forge Dental Association, stated "...these two individuals and this important access to care program are eminently qualified to be the recipients of the Pennsylvania Dental Association Public Service Award."

Since 2009 Miles of Smiles has had 12,000 visits and its staff has performed 40,000 procedures. Ms. Atno and Dr. Kosteva have utilized their grant writing skills and contacts with the Foundation of the American Academy of Pediatric Dentistry and its Healthy Smiles, Healthy Children Initiative in order to secure the necessary funding for this wonderful initiative.

PDA RECOGNITION AWARD

Dr. Susan Chialastri has dedicated her life to exceptional service, research and instruction in the science of dentistry. With more than 40 years of experience, she is an esteemed educator who has enthusiastically contributed her knowledge and expertise to mentoring countless students.

Dr. Chialastri's career in dentistry and higher education started as a Professor for the Department of Dental Radiology at Temple University School of Dentistry in 1979. She has since then worked as an instructor at several institutions – including the University of Pennsylvania and Harcum College. Since 2004, she has been the Assistant Professor of Pediatrics at Drexel University College of Medicine and is currently Associate Professor of Periodontology and Oral Pathology and Predoctoral Periodontology Clinic Director at Temple's Kornberg School of Dentistry.

In the nomination letter for the 2016 PDA Recognition Award, Dr. Amid Ismail, Dean of Temple's Kornberg School of Dentistry, said, "Dr. Chialastri's experience and willingness to share her expertise with students enables the transfer of knowledge that sustains important foundational structures of dental education."

Dr. Chialastri holds a bachelor's degree in education from Temple University (1974) and earned her DMD from Temple University School of Dentistry in 1987. Her path of education continued on as she received a post graduate certificate in periodontics at Penn and a master's of science degree in Oral Biology from Temple in 2009. Starting in 1972, Dr. Chialastri worked in dental hygiene private practice in Philadelphia for 17 years, followed by 18 years in Periodontics and Oral Implantology private practice in the Philadelphia region.

All the while she has continued to serve organized dentistry, including a term as a member of the Board of Governors of Philadelphia County Dental Society, and has served as the Kornberg School's American Student Dental Association (ASDA) chapter faculty adviser since 2009.

Dr. Chialastri has an impressive history of lectures, courses, and seminars in Periodontal Therapy and Treatment, an area in which she commands a vast in-depth knowledge. She has received countless awards recognizing her contribution to dental education over the years, including numerous faculty awards from Temple, and in 2012 was given the Advocate Award from ASDA.

2015 ADA MEMBERSHIP PROGRAM FOR GROWTH SUMMARY

The ADA Membership Program for Growth (MPG) allows societies to apply for grant funding to conduct new programs that aid in membership recruitment and retention. In 2015, PDA conducted four programs, listed below, that were sponsored by the ADA's MPG.

WHITE COAT CEREMONY

PDA leaders attended the White Coat Ceremony at Temple University in May of 2015. PDA President Dr. Wade I. Newman spoke at the ceremony where approximately 140 students from the Class of 2017 received their white coat. PDA was a sponsor of this event.

ADA 2015 STUDENT BUS

PDA was granted funding to sponsor a student bus for ADA 2015. In November of 2015, 47 dental students from the University of Pennsylvania and Temple University utilized the bus transportation to attend a day at ADA 2015 in Washington, D.C. Each class was represented on the bus trip (Class of 2017 saw the highest percentage of student participants at 57 percent).

Students were able to explore the Exhibit Hall, attend CE courses and network with member dentists. All of the students surveyed said having free bus transportation had influenced their decision to attend ADA 2015.


Number and Market Share of PDA Members 2005 - 2015 vs. Pennsylvania Active Licensed Dentists





GOVERNMENT RELATIONS

PDA'S TOP FOUR ADVOCACY GOALS FOR THE 2015 - 2016 LEGISLATIVE SESSION

PDA is the premier dental organization at the forefront of legislative initiatives to improve the dental practice environment in Pennsylvania for both dentists and patients. We are more than halfway through the legislative session. For the remainder of 2016, PDA's lobbyists, staff and volunteer leaders will work on members' behalf to pass these important insurance reforms, and scope of practice and access to care initiatives:

- Assignment of benefits for all providers.
- Limiting time frame insurers may retroactively review and deny claims.
- · Health practitioner student loan forgiveness.
- Restoration of funding in the adult Medical Assistance program for dental providers

GENERAL ASSEMBLY UPDATE

Assignment of Benefits (HB 973 and SB 843)

PDA is lobbying for enactment of assignment of benefits legislation, having spent last fall working with Senate and House leaders and staff on language that satisfied their concerns about adequate consumer protection safeguards when they need dental treatment in emergency situations.

Retroactive Insurance Claim Reviews (SB 554 and HB 1178)

PDA is playing a prominent role in a coalition of other health care provider groups lobbying for passage of legislation that would limit the time frame in which insurers may retroactively review and deny claims to 18 months.

Student Loan Forgiveness for Practicing in Underserved Areas (HB 1276)

PDA supports legislation increasing the loan repayment to \$200,000 for dentists who are part of the Primary Care Loan Repayment Program. In exchange, dentists must commit to practicing full-time for two years.

GOVERNOR'S ADMINISTRATION UPDATE

PDA advocates for the profession with Administration policymakers to advance new policies or policy reform in the executive branch of government. We represent dentistry when working with officials from the Departments of Human Services, Health, Environmental Protection and Insurance.

Department of Human Services: Medical Assistance funding

PDA continues to lobby for the restoration of funding in the adult Medical Assistance (MA) program to at least the 2010 level. The decision to limit most essential services for adults resulted in increased cost to taxpayers when adults do not get the services they need and eventually seek treatment in hospital emergency rooms.

Department of Health: Regulation of dental laboratories

PDA is encouraging DOH to consider adopting regulations or internal policies to ensure more accountability from dental laboratories, including requirements for the following:

- Reporting the point of origin for where the device or material is fabricated.
- Disclosing materials contained in dental prosthetics.
- Registration of out-of-state laboratories doing business in Pennsylvania.
- Dental labs employing at least one certified dental technician.
- Certified dental technicians obtaining continuing education credits.

Department of Insurance: Balance Billing

The Department of Insurance is proposing legislation regarding the issue of balance billing, which occurs when a patient receives a bill for health care from a provider who is not in-network with the patient's insurance company. PDA submitted testimony to the Department to clarify how the issue of balance billing works in dental offices. We will continue to monitor the department's activities to ensure that any policies or regulations that are promulgated do not negatively impact dentists' billing procedures.

PENNSYLVANIA COALITION FOR ORAL HEALTH MAKES STRIDES IN IMPROVING ORAL HEALTH CARE FOR ALL

The Pennsylvania Coalition for Oral Health (PCOH) is comprised of a diverse group of leaders from across the state from schools of public health, philanthropic organizations, businesses, dental organizations, health insurance plans, advocacy organizations, state agencies and other champions. PDA is a founding member of PCOH and several members serve in leadership positions, helping to steer the direction PCOH takes on policy and other oral health care initiatives.

PCOH advances policies and practices that increase access to oral health services, education, and prevention especially for our most vulnerable Pennsylvanians. Its mission is to "actively promote evidence-based preventive services and research; promote and fund strategies that will increase the oral health workforce capacity and effectiveness; and, fund oral health infrastructure in the Pennsylvania Department of Health."

SBOD UPDATE

NEW REGULATIONS FOR DENTISTS

This year Pennsylvania State Board of Dentistry (SBOD) is working to finalize a number of regulatory proposals, many of which will impact how you run your office. Here are new regulations you can expect to take effect sometime in the near future:

ANESTHESIA PERMIT HOLDERS:

Proposed regulations will update the standards for anesthesia permit holders. There will be new regulations pertaining to the issue of administering oral sedatives and "stacking" medications.

CHILD ABUSE REPORTING REQUIREMENTS:

Proposed regulations will update the SBOD's existing regulations to include the new requirements for applicants and licensees to obtain the required amount of training and continuing education in child abuse recognition and reporting.

GENERAL REVISIONS OF 49 PA. CODE:

The SBOD reviewed existing regulations with the goal of updating regulations and updating outdated and obsolete provisions. There will be a brand-new requirement for dentists to install an AED in their offices.

SCHEDULE OF CIVIL PENALTIES:

The SBOD proposed increases in the amounts in the schedule of civil penalties for lapsed license/certificate violations. The SBOD believes that it is necessary to increase the civil penalties to deter prospective violators.

RESTRICTED FACULTY LICENSES:

New regulations will allow for restricted dental school faculty licenses, which are granted to individuals for the limited purpose of teaching in a dental school or advanced dental education program as a faculty member of an accredited dental school.

TEMPORARY VOLUNTEER DENTAL

LICENSES: Act 7 of 2014 established the procedures in which to apply for a temporary volunteer dental license. The purpose of Act 7 of 2014 is to allow for out-of-state dentists to volunteer their services in Pennsylvania at charitable events sponsored by PDA or other organizations.

What's on the horizon? Stay tuned as the SBOD explores whether to promulgate regulations pertaining to issues such as sleep apnea, botox injections, teeth whitening services, corporate dentistry and mobile dentistry. PDA will continue to monitor all SBOD activities, submit comments and keep members informed of new regulations that take effect.

PDA cannot accomplish its legislative goals without a financially sound PAC.

PADPAC ensures that dentistry's interests are properly represented in Pennsylvania.

What is PADPAC?

A political action committee is an organization that pools contributions from members and donates those funds to campaigns. Due to state and federal laws, PDA has categorized PADPAC funding into two categories. When deciding how to appropriate PADPAC contributions, PDA must distinguish how donors make their contributions:

Hard Dollars: Contributions made with a personal check or credit card. Only hard dollars may be used for political campaign contributions.

Soft Dollars: Contributions made with a corporate check or credit card. Only soft dollars may be used for administrative purposes such as assisting district or local dental societies with a fundraising event.

For decades, PDA's PADPAC has built its statewide reputation by supporting candidates and causes that ensure dentistry achieves its professional and advocacy goals in Pennsylvania.

PADPAC does not make contributions based on party affiliation. Instead, PADPAC works to build a positive relationship with legislative candidates through its government relations staff, lobbyists and donors. It's critical to have access to voice dentistry's position on legislative and regulatory proposals. The PADPAC board determines contribution levels upon the advice of our lobbyists, staff and donors.

PADPAC cannot achieve its goals without a strong grassroots foundation. PDA members from across the state comprise this grassroots network and they help us determine how to reach out to candidates and promote our legislative priorities. Through PADPAC, members can get to know their local legislators and speak for their profession. All PADPAC members comprise an effective lobbying force at the local level.






THE INCOME STATEMENT THROUGH DECEMBER 31, 2015, SHOWS A DEFICIT OF \$4,839.











PDAIS/Bell exists to provide competitively priced, quality insurance products to their clients, their employees and families, as charged through the endorsement of the Pennsylvania Dental Association. The five key measures that help us understand whether or not PDAIS/Bell is following its mission and doing its job can be defined by our commitment, high ethical standards, growth, customer service and quality products. While practical measures are not necessarily indicators of health and depth of commitment, they do serve as barometers that help us ask the appropriate questions. This year-end report will attempt to highlight in abbreviated fashion the accomplishments of the past 12 months.

PDAIS/BELL 2015 HIGHLIGHTS:

Products/Growth

- •PDAIS acquired Bell Insurance agency on November 1, 2014. The importance of an agency acquisition was mainly due to the implementation of the Affordable Health Care Act (ACA). The ACA, unfortunately, has had an adverse effect on PDAIS's revenue and the long-term prospect of PDAIS fulfilling its mission to serve PDA dentists and provide revenue to the PDA.
- The Bell acquisition provides PDA with an even more valuable asset and a broader portfolio of products for PDA members. However, we can assure you that PDAIS' focus and mission will be to continue to serve our dental community and clients. Perhaps most importantly, our member's clients will not experience any negative changes or deterioration in service they have grown accustomed to receiving.
- PDAIS's overall written premium is \$16,200,990 with a total revenue of \$1,190,057.
- •PDAIS experienced increased growth for 2015, with TDIC increasing by 2% in new client growth and 4% in written premium growth. TDIC granted PDAIS for the 12th consecutive year a dividend of 6%. Mid-Atlantic Insurance Resources growth was up 15% in new client growth, but 7.4% in written premium growth and a fifth consecutive dividend of 6%. The total TDIC PDA member penetration is 14%.
- •Offers free malpractice for the volunteers at the Mom-n-PA event.
- •The workers compensation program with Eastern Alliance Insurance group grew by 12% in written premium with a three-year loss ratio of 19.6%. For the second consecutive year we received the "Best in Class" agency award, which is a very prestigious award.
- •Our Business Property program with Liberty Mutual grew by 8% in written premium with a three-year loss ratio of 35%.
- The benefits department continues to struggle with new business, due to the challenges with the full implementation of the ACA. We had a decrease in new business sales and a decrease in total written premium. This is due to the transferring of clients from the 21 County health insurance program, written through Capital BlueCross.
- •On March 2015 we added The Affinity personal lines program through Donegal Insurance Company. This provides all member dentists a 5% discount on Auto and Home Owners Insurance.
- •During all this growth and challenges the agency is still able to maintain an overall retention of 88%.
- Wrote a number of disability, life and long-term care insurance policies.
- Bell Insurance grew by 17% in written insurance premium and 6.2% in gross revenue.

PDAIS

COMMITMENT

- •PDAIS completed its sixth year managing the PDA Endorsed programs, which experienced a 30% decrease in royalty revenue. The total revenue in 2015 was \$134,161 vs. \$174,940 in 2014. This is due to the poor fourth quarter of the Bank of America Practice Solutions; the discontinuance of the BofA credit card program for 2015. However, we were able to replace the credit card program with the ADA program.
- •PDAIS continued to provide non-dues revenue to PDA and local dental societies, totaling \$125,456.11, for a 16-year total of \$2,808,665.
- •PDAIS sponsored and attended 53 CE programs and study clubs throughout the commonwealth and 7 programs in New Jersey.
- PDAIS continues to perform significant marketing campaigns in the attempt to increase sales and education of PDA and NJDA dentists.
- •The PDAIS Benefits department is providing assistance to PDA members during this monumental change in the Health insurance environment.
- •PDAIS' financial support was able to contribute to the success of PDA's New Dentist and Student Outreach Programs and continued its financial support of the PDA Annual Meeting again this year.

FINANCIAL STATEMENTS

PDAIS - As indicated on the financial statements (page 35), in 2015 we experienced a decrease in overall gross revenue of -31.4%. The decrease is due to the dissolving of our 21 county association health plan and moving all clients either to individual plans or group plans direct with carriers. However, we were able to decrease expenses by \$358,452 (20.8%). This results in a net loss of (\$205,913). Also, remember that \$125,456 of the PDA marketing fee and local royalty dollars would be considered as a return of profit in net income in a standard insurance agency mode, which would bring a net income loss of (\$80,457).


Bell Agency - As indicated on the financial statements (page 36), Bell experienced an increase in overall gross revenue of 8.0%. There was a decrease in expenses of 5.2%. We ended the year with \$651,276 in net income.

THREAT

In 2015 PDAIS experienced the full impact of the Affordable Care Act, as reflected on our decrease in revenue, due to the dissolution of our 21 County Association health insurance program. Our short-term threat is maintaining a balanced cash flow until the debt is paid. We currently have a strong income statement, but until we pay off the debt we will need to stay disciplined in managing our operations.

OUTLOOK

As the health care industry still remains uncertain, we believe the worst is behind us. Our focus is to grow the combined agencies in every facet of the business, but we are currently focusing on growing the property and casualty business. With the new processes that we have implemented, along with the Bell agency acquisition, we are positioned for positive growth in the future.
